Terms for Real Estate Auction

1. Property is Sold "AS IS" with no contingencies, and No Warranty either expressed or implied with respect to the nature and description of acreage and usage, subject to conditions, easements, agreements, restrictions and covenants of record is offered.
2. All "Closing Costs" are to be paid by the Buyer.
3. A \$15,000 (Nonrefundable to the Winning Bidder) deposit is required PRIOR to the Auction. Non Winning Bidders will have their Deposits refunded upon Winning Bidder Signing Sales Contract.
4. The Buyer has 30 Days to Close, In the event that the transfer of title has not occurred in 30 Days, the purchaser shall be charged daily Interest that shall be paid on the unpaid balance amount at the rate of 1% per month beginning 30 Days after the Day of Auction, xx xx xxx, to the date of transfer of title.
5. A 10% buyer's premium shall be paid on the final bid price and included in the contract price.
6. The winning bidder's pre-registered Agent shall be paid a 3% commission on the Final Bid Price.
7. The property is sold free and clear of all liens and encumbrances. Time is of the Essence.

Terms on Personal Property Auction

1. The highest bidder for each lot shall be the buyer. If any dispute arises as to the bidding or between two (2) bidders, the lot so disputed shall be immediately put up again at the last undisputed bid and resold. The auctioneer has the final discretion to determine the successful bidder. At our discretion we will execute order or absentee bids or arrange telephone bids as a convenience to clients, but are not responsible to execute any absentee bids. If a dispute arises after the sale, our sales record will be conclusive. All legal actions concerning sales will be arbitrated/adjudicated in the Sole and Exclusive venue of Hampton, Virginia Courts.
2. Each lot shall be at the buyer's risk from the fall of the hammer and shall be paid for and taken away by the buyer at the end of each day's selling. Phoebus Auction Gallery will not be responsible for loss or damage to property, which is not removed from our premises on the day of the sale. The packing and handling of purchased lots by us is at the entire risk of the purchaser.
3. The auctioneer at her discretion may reject any bid not commensurate with the value of the article offered. We reserve the right to reject any bid or withdraw any lot from the sale.
4. Auctioneer is not required to cut bids, but will proceed at even increments unless, at his/her discretion, it is necessary to **enhance the sale. Some of the lots in this sale are being sold subject to a reserve. A "reserve" is a confidential minimum** price agreed between consignor and the Phoebus Auction Gallery below which a lot will not be sold. We may implement reserves by bidding on behalf of the consignor.
5. All items must be paid for in full and removed on the day of sale unless other arrangements have been made and are so noted on receipt. The Gallery Can Provide Shipping Services when requested. Items left at the Gallery are at the owner's risk. A representative of the gallery will be on-site from 10 am to 4 pm Monday, December 5th 2022 for pickup of items. NO security is provided and items left after 4 pm, December 5th 2022 are forfeited.
6. All sales are for cash, Visa, Master Card, Discover, and business or personal check with valid ID. Unless exempted by law, all individuals will be charged Virginia sales tax of 6% of the purchase price and buyer's premium.
7. A buyer's premium of 22% of the successful bid price will be added to the total purchase price of all properties to be paid by purchaser as part of the total purchase price. The Buyers Premium for the Catalina 30 Sail Boat is 15%.
